Voter Updates:

Did you know that many Ohio Voters do not vote for judges? Many say that they do not know enough about the candidates themselves. Others say they do not understand the judicial system in Ohio well enough to weigh in. This can be very problematic. For example, in 2018, Ohio voters will elect judges to the Supreme Court of Ohio and all 12 districts of the Court of Appeals, as well as most courts of common pleas and county courts but if we are not all voting on the judges, we may not get the judges that most represent our values. But there is help...

Ohio Supreme Court Chief Justice Maureen O'Connor brought together the League of Women Voters of Ohio, the Ohio State Bar Association, the Ray C. Bliss Institute of Applied Politics at the University of Akron, the Ohio News Media Association, and the Ohio Association of Broadcasters to better educate Ohioans about judges and the Ohio court system, as well as to increase voter participation in judicial elections. Ohio Redistricting Reform Updates:

The LWVOhio has joined the Ohio ACLU and 16 individuals, one from each Ohio Congressional district, in a suit over the extreme gerrymandering of the Ohio Congressional map. The defendants are the Ohio Governor, Secretary of State, the Protem Speaker of the House, and the President of the Senate. The suit contends that the map violates the 1st and 14th Amendments of the U.S. Constitution.

Because the recent passage of Issue 1, Fair Districts, will not take effect until after the 2020 census, probably in 2022 and because it will take time to redraw the districts, the LWV and ACLU aim to effect an earlier redrawing of the map by winning this suit. The lines could then be redrawn before the 2020 election.

New analytic techniques can prove that 6 elections in the past decade have been affected by gerrymandering; it is this information that enables the suit to be brought at this time.

With civil rights and democracy increasingly under attack, the strength and impartiality of our courts is essential for achieving justice on all of our issues. Delaware City Planning Commission Report:

Meeting of June 6, 2018
The first item of business on the Commissions Agenda was both unique, interesting and controversial. Planning Staff presented the following proposal to the seven members. Manos Development has purchased the Perkins House (built by Hiram Perkins, an astronomer and Ohio Wesleyan Professor of many years about 1900) and the property next to it (235 and 239 W. William St.). Manos proposes to renovate and restore the handsome Perkins house, add a sizeable addition on the back and establish a boutique hotel on the property, to be named The Wesleyan Inn. The neighboring house would be raised and the space used for a parking lot. The proposal to the Planning Commission asked for rezoning of the two properties to create a Planned Mixed Use Overlay District, and requested approval of a Preliminary Development Plan for The Wesleyan Inn.

The proposed addition (containing the bulk of the Inn's 43 rooms) would be three stories high, with a cornice line consistent with the historic home. The home was at one time a fraternity house, but is not now occupied. A number of existing trees would be removed and the developer would be required to either replace the caliper inches or pay a fee to the city in lieu of replacement. A left-turn lane on westbound William St. is proposed and the City Engineering Dept. suggests a "bump in" in front of the houses on the north side of William St. to make room for the turn lane to be added. City Planning Commission policy allows public comment on all proposals that come before it, and there was much comment on this proposal. Residents in the area objected to an Inn adjacent to the homes to the north. The developer responded that he is in process of purchasing the first house north and will convert it to a rental. That brought other objections from those in attendance. Owners across the street from the property raised concerns about the additional traffic and congestion on William St. and the fact that "bump-in" spaces for parking would reduce the already very narrow tree lawn.

Other concerns voiced were the nature of the Inn occupants; i.e., transients; noise from gatherings on the outdoor deck; loss of property values; and loss of privacy due to the height of the building in that neighborhood. A member of the Historical Preservation Commission (HPC), speaking for himself only, asked that a Condition be added to any approval, that required the Developer to consult with and get approval from the HPC of any outside renovations, so as to assure the authentic restoration of this historically significant building.

The Planning Commission members, the Developer and Planning staff, responded to the concerns raised but did not totally satisfy the complainants. After 1 hour 50 min. the Planning Commission moved to approve the proposal as recommended by staff and it passed unanimously. The proposal for a Preliminary Plan now goes to City Council for approval. If approved, the Developer will proceed with detailed plans, will need to work with City Engineering re the William St. issues, etc. and if all issues can be resolved, will return to the Planning Commission with a proposed Final Development Plan. Watch for more on this interesting project. Note: The 4 additional projects on the Agenda took one hour.
